Summary of Proposed Ordinance and Statement of Public Purpose to be Served Summary of Proposed Ordinance: AN ORDINANCE OF THE VILLAGE COUNCIL OF MIAMI SHORES VILLAGE, FLORIDA, AMENDING CHAPTER 20, "STREETS, SIDEWALKS AND OTHER PUBLIC PLACES," ARTICLE II., "STREETS" TO UPDATE REGULATIONS GOVERNING SIDEWALKS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING FOR CODIFICATION; PROVIDING FOR AN EFFECTIVE DATE

<u>Statement of Public Purpose to be Served</u>; According to Sec 20-23 of Miami Shores's municipal code, maintenance of sidewalks is the responsibility of the private owners against whose property the sidewalk abuts. In order for the Village to participate in the maintenance of efforts, an amendment to Sec 20-32 of the Village's code requirement is required. The amended code provides for the Village's participation under conditions where factors arise outside a property owner's control, such as damage caused by the Village or Village-owned property infrastructure or natural elements, including tree roots. Village administration would be required to repair, install, or replace the sidewalks that deteriorate under the above conditions.

Use of facilities by residents: Sidewalks in Miami Shores are conduits for pedestrian movement and access to public and private facilities. They enhance walkability and promote a healthy lifestyle. Properly constructed and maintained sidewalks are a public necessity for pedestrians' safe use of the ROW and lead to the maximization of social capital. By regulating ownership and maintenance responsibility, the Village will be able to hold stakeholders responsible for the upkeep of the sidewalk.
